



Limited Product Warranty

This limited warranty is provided by Pelican Wireless Systems (PELICAN) for any and all product developed and manufactured by PELICAN which reside exclusively under the Pelican Brand (FOUNTEN Brand products (FOUNTEN is a trademark owned by Carrier Enterprise LLC) are excluded from this warranty and are covered under a separate Limited Product Warranty. This limited warranty applies only to hardware components. Pelican does not include any warranty for damage caused by normal wear and tear, accidents, misuse (including failure to follow product documentation and plugging the device or other included parts into the wrong type of electrical circuit), neglect, disassembly, alterations and external causes such as but not limited to extreme thermal or environmental conditions (including but not limited to moisture and heavy dust), installation or enabling of unauthorized software or service, unauthorized alterations to product software or services, or unauthorized resale. This limited warranty does not guarantee that usage of product will be error free.

EXCLUSIVE REMEDY: We warranty the Device against defects in material and workmanship under ordinary consumer use for five years from the date of original retail purchase. During this warranty period, if a defect arises in the Device, and you follow the instructions for returning the Device, we will, at our option, either (i) repair the Device using new or refurbished parts at a fixed customer cost of \$35.00 per Device or (ii) replace the Device with a new or Factory refurbished Device. This limited warranty applies to any repair, replacement part or replacement Device for the remainder of the original warranty period or for ninety days, whichever is longer.
